

Privacy Policy

Introduction

This Privacy Policy explains how personal information is collected, used, disclosed, and protected when you access and interact with this website. This website operates as a promotional and lead generation platform for third-party gaming and entertainment partners. By using this website and submitting your information, you agree to the practices described in this policy.

Age Restriction

This website is intended strictly for individuals who are at least 21 years of age (or the legal gambling age in their jurisdiction, if higher). We do not knowingly collect personal information from individuals under this age.

Information We Collect

We may collect personal information that you voluntarily provide, including your email address and other information submitted through forms. We may also automatically collect technical information such as IP address, browser type, device data, country, region/state, and usage data.

How We Use Your Information

Information collected may be used to process registrations, deliver promotional communications, provide access to partner offers, analyze traffic, improve website functionality, comply with legal obligations, and detect or prevent fraud and abuse.

Marketing Communications and Consent

Affiliate and Advertising Disclosure

Sharing of Information

Personal information may be shared with licensed gaming operators, marketing partners, service providers, analytics providers, and technology vendors for the purposes described in this policy. These third parties process information according to their own privacy policies.

This website may use cookies, pixels, tags, and similar tracking technologies for performance measurement, analytics, advertising, and user experience optimization. Third-party advertising platforms may collect data about your interaction with this website. You may control cookies through your browser settings.
